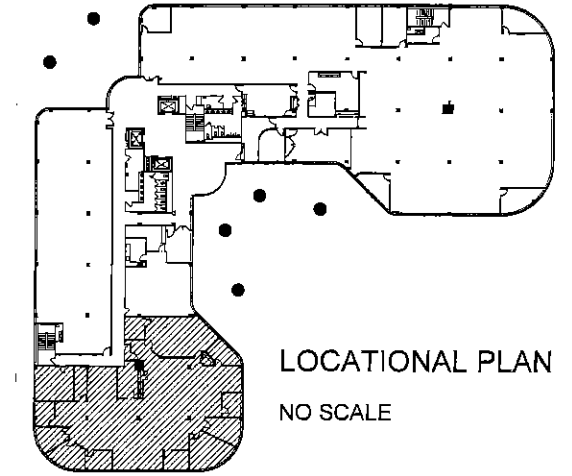


BP-2, FLOOR PLAN, THIRD FLOOR
